SHIPPING AND HANDLING CHARGES WAIVED ON ALL ORDERS OVER \$5,000.00 FOR THE CONTINENTAL U.S.A

ORDER: Unless in stock, orders will require 8 – 12 weeks for delivery. Please allow additional time for UPS and postal deliveries.

ALL ORDERS: The minimum opening order is \$500.00. All shoe orders must be prepackaged by case. A case is consistent of 12 pair same style and color; however, customers select the desired size range. The size range begins at a size 13 child thru size 11 adult. All apparel orders are prepackaged by ½ case. A ½ case consist of six pieces same style and color. The size range is small, medium, and large for children and adult. All orders must be accompanied by a 50% deposit. Please print and double check your order. Please remember orders are processed by style names not names. If you reorder, please use the same shipping information.

FAX AND TELEPHONE ORDERS: We will accept fax and telephone orders only for credit card sales. Orders by check must be mailed to 9901 Business Parkway, Ste. L, Lanham, Maryland 20706. All orders will be confirmed by our office by our office within 10 days of receipt order.

DEPOSITS AND PAYMENTS: 1. All orders must be accompanied by a 50% deposit.

SHIPPING AND HANDLING:

1. Please note there is a handling charge of \$10.00
2. Orders in excess of \$5,000.00 are shipped free in the continental of US.
3. C.O.D charge is \$12.00 plus UPS and/or Federal Express fee. Available only in the U.S.
